IT'S CONVENIENT

Pre-authorized giving is a giving option available at no charge to you. It eliminates the need for you to write a cheque each month for your donation.

IT'S ASSURED

If you are away on vacation, out of town on business or sick, your offering will be made ensuring the continued ministry of the Diocese.

HERE'S WHAT TO DO

- Whatever you now give weekly, monthly, quarterly, or annually, simply convert to a monthly or semi-monthly amount.
- Fill in the attached form and enclose it with a cheque marked "VOID" and send it to Heather Moller c/o of Church House.
- Your offering will be deducted from your bank account monthly on the 10th or the 25th in the same way you honour many of your other commitments in your life.

WHAT ABOUT RECORDS?

Donations are recorded automatically and individually on your monthly bank statement or passbook. These donations are recorded at the Church House office and included on your annual tax receipt.

IF YOUR CIRCUMSTANCES CHANGE

Each donation shall be the same as if I\we had personally issued a cheque authorizing the bank to pay the Diocese as indicated and to debit the amount specified to my\our account.

At any time the amount of your offering can be changed. Simply notify Heather Moller of the change. If the banking information has changed, please provide a new "VOID" cheque.
